## **MISSION STATEMENT**

## **PROFILE OF A PCA STUDENT**

Providence Christian Academy students will continually seek to grow spiritually, academically and socially based upon a theologically sound, Christian worldview. Students will seek Him first in all that they do and will lead mission-minded lives with a heart that desires to share the love of Jesus Christ with others, making disciples who make disciples.

## STATEMENT OF FAITH

Gwathmey Baptist Church and Providence Christian Academy upholds the following doctrines of our Christian faith:

- There is one Triune God who is the creator and ruler of the universe. He has eternally existed in three persons: The Father, the Son, and the Holy Spirit. These three are co-equals and one God.
- God the Father reigns with providential care over His universe. He is all- powerful, all knowing, all loving, and all wise.
- Jesus Christ is the only Son of God. He is fully God and fully man. He was born of a virgin, lived a sinless human life, and offered himself as the perfect sacrifice for the sins of all by dying on a cross. He arose from the dead after three days to demonstrate His power over sin and death and ascended into heaven where he sits at the right hand of God.
- The Holy Spirit is present in the world to make people aware of their need for Jesus Christ. He lives in all Christians from the moment of salvation, providing them with power for living and guidance in doing what is right.
- The Bible is God's written revelation of Himself to mankind. We believe the Holy Scriptures of the Old and New Testament to be the fully verbally and plenary inspired Word of God. The Scriptures are inerrant, infallible and God-breathed, and therefore are the final authority for faith and life. The sixty-six books of the Old and New Testament are the complete and divine revelation of God to Man.

## **EDUCATIONAL OBJECTIVES**

Our objective is to provide a Christ-centered education that not only meets but exceeds Virginia state academic standards. We are committed to equipping students with strong foundational skills (in reading, writing and math), fostering curiosity and critical thinking in all subject areas, and integrating biblical truth into every area of learning. We will enhance learning through a variety of resources and enrichment classes. In doing so, we seek to cultivate character, responsibility, and a lifelong love for learning.

## **PHILOSOPHY OF CHRISTIAN EDUCATION**

Our philosophy of education is rooted in the conviction that all truth is God's truth and that the purpose of learning is to glorify Him. We view education as the holistic formation of the student—intellectually, spiritually, socially, and morally—so that each child may develop a Christ-centered worldview. We are committed to cultivating academic excellence, critical thinking, and moral integrity while integrating biblical truth into every area of study. In doing so, we seek to prepare students not only for future academic success but also for faithful service to God and others.

## **ADMISSIONS**

We welcome applications from all Christian families. In keeping with the mission statement of the church and school, we seek excellence in Christ as well as diversity in our student body.

### **Non-Discrimination Policy**

Providence Christian Academy is a Christ-centered school dedicated to providing an excellent education rooted in biblical truth. We admit students of any race, color, national and ethnic origin to all the rights, privileges, programs and activities generally made available to students at the school. We do not discriminate on the basis of race, color, national and ethnic origin in the administration of our educational, admissions, scholarship, or other school-administered programs, while upholding our mission to partner with families in Christian education.

## **NOTE ABOUT ENROLLMENT FOR 2026-2027**

We are a start up school and as such will be enrolling on a gradual basis until we are fully enrolling grades preschool through fifth grade. We are currently specifically looking at junior kindergarten, kindergarten, and first grade for the 2026-2027 school year. Students must reach age 5 by September 30th to be eligible for kindergarten. Our junior kindergarten program is specifically for children who will be age 4 by September 30th and will enter Kindergarten the following year. We will reach out if we are unable to accommodate your student in the current school year.

## **FUNDRAISING**

Families are requested to participate in school fundraisers throughout the year. We try not to have families sell items and instead focus on fundraising events and spirit nights. Please plan to attend as many fundraisers as possible and share these events with your family, friends and neighbors. Fundraising events will help us to expand and improve the school.

## **HOURS OF OPERATION**

School hours are Monday through Friday from 8:30AM to 2:30PM. Students may not be dropped off prior to 8:15AM and must be picked up promptly at 2:30PM. The school reserves the right to apply a late fee to the account for students habitually not picked up by 2:45PM. Students will be dismissed at 11:30 AM on days designated as Early Release days. The 2026-2027 school year runs from August 31st through June 4th.

## **ACADEMICS**

Elementary education is the vital foundation that students will rely on all throughout middle school, high school, college, and beyond. This foundation is incredibly important and needs to challenge students to think independently and critically. At PCA, we use a traditional curriculum along with a variety of innovative learning strategies and activities to enhance daily lessons. BJU Press curriculum is used for all subjects in all grades. Our

curriculum has a strong biblical worldview and scripture is woven and tied in throughout all subjects. Our core academic classes meet Virginia state standards. For reading, we focus on phonics and developing strong reading comprehension skills, including higher-order thinking skills. Language Arts, which includes writing, grammar, and spelling, is taught using a rigorous Christian-based curriculum. PCA math standards are taught using a variety of resources focusing on basic math skills along with problem-solving skills and strategies. Bible class is taught daily, and students attend chapel once each week. Social studies and science complete the well-rounded academic program. We recognize that God created each person intentionally and uniquely and as a result not everyone learns the same way. We use a variety of instructional styles, methods and tools to enhance learning and ensure that we are meeting the needs of every student where they are.

Spiritual highlights include: weekly chapel service, Bible studies, character development, application of biblical truths, scripture memorization, and prayer.

Enrichment classes include: Physical Education, Art, Music, Spanish, STEM, Technology, and daily recess.

Special events include: field trips, spirit days, school picture day, and more!

## **CURRICULUM**

### **PCA uses BJU Press for all core subjects and Bible class.**

About BJU - "Biblical worldview shaping is at the heart of all the materials we design. Students learn how the Bible is relevant to every academic subject because each textbook includes biblical worldview shaping. Instead of beginning with man's assumptions and then refuting them with God's truth, we start with God's truth as the standard. Scripture serves as a blueprint for how we put together our textbooks so that every lesson begins with truth."

### **Bible**

GBC & PCA use the English Standard Version Bible. Students are welcome to carry one of the following versions of the Bible that they prefer: ESV, CSB, NIV, NIRV, KJV, NKJV, or NASB.

## **GRADING SCALE**

Grades are calculated in different ways at PCA depending on the course and grade level. Core academic courses use the traditional ABCDG grading system for all grades K through 5. Junior kindergarten plus Bible and enrichment classes (for all grades) use the OSNF grading system.

The following two scales are used:

**90-100 = A**

**80-89 = B**

**70-79 = C**

**60-69 = D**

**Below 60 = F**

**Outstanding = O**

**Satisfactory = S**

**Needs Improvement = N**

## **REPORT CARDS**

Parents will have access to weekly grade updates. Please check your child's daily folder to monitor progress. Grades will also be available for viewing via the FACTS portal.

Official report cards will be made available four times a year following each of the four quarters. Parents have 2 weeks from the date that report cards are posted to dispute any grade or attendance issue. After that time all grades and attendance records stand and may not be disputed.

## **ATTENDANCE**

At Providence Christian Academy, regular attendance is vital for your child's learning, spiritual growth, and participation in our school community.

What We Expect:

- Students should attend school every day, on time, and ready to learn.
- Parents should notify the school via phone or email as soon as possible if a student will be absent.

- Students are required to bring in a note from home on the day they return to school after being absent.

#### General Attendance Policies:

- Any student missing 5 or more consecutive days of school must submit a doctor's note before returning to school.
- Any unexcused absence or tardy may result in a zero grade for missed assignments.
- Parents will be notified via a letter home when a child has missed 10 days of school (excused or unexcused).
- Any student with 15 or more absences (without medical documentation) will be reviewed for possible course failure or grade retention.
- Any student who is tardy (excused or unexcused) for 5 times in a quarter must meet with administration before the student can return to school.
- Excessive absences, tardiness, or early dismissals may affect future reenrollment eligibility.

#### Excused Absences:

- Illness or medical appointments
- Family emergencies
- Other approved circumstances

#### Tardiness:

- Arriving on time is important for learning and for respecting others in the classroom.

#### Make-Up Work:

- Students are responsible for completing assignments they miss. Teachers will guide how and when to make up work.

#### Our Perspective:

- Being present at school is not only about academics—it's about being part of a Christ-centered community where each student's presence matters.

#### Support:

- We understand that life can be challenging. Please communicate with us so we can help your family maintain consistent attendance.

## **ILLNESS**

To protect the health and safety of all students and staff, children who are sick should remain at home until they are symptom-free without the use of medication for at least 24 hours. This includes, but is not limited to, fever, vomiting, diarrhea, contagious infections, or severe respiratory symptoms. Families are asked to promptly notify the school of any contagious illnesses. The school reserves the right to send a student home if they display symptoms of illness during the school day and the student must be picked up within one hour of the request. During a medical emergency, if a parent or emergency contact cannot be reached, the school will call 911 for assistance.

## **MEDICATION**

Whenever possible, parents or guardians are encouraged to have doctors schedule medication doses outside of school hours. All medications, with the exception of EpiPens for severe allergic reactions, should be given at home before school begins or after dismissal. Providence Christian Academy does not provide administration of prescription or over-the-counter medications at school, and a signed parental release is required if medication is deemed medically necessary while at school (but this is only in special, unavoidable circumstances). EpiPens may be stored in the classroom with the teacher or in the school office.

## **HOLIDAYS**

Providence Christian Academy will be closed in observance of Labor Day, Thanksgiving, Christmas, Easter, and Memorial Day to allow students, families, and staff time for rest, celebration, and reflection. A school calendar will be provided each year outlining all scheduled holiday breaks and any planned teacher work days. Families are encouraged to plan accordingly.

## INCLEMENT WEATHER

We will follow the Hanover County Public School closures for inclement weather. We will send emails out as promptly as we can.

## DRESS CODE

At Providence Christian Academy, we believe that how we dress reflects our values, creates a positive learning environment, and honors God. Our dress code encourages modesty, neatness, and respect while allowing students to be comfortable and active throughout the school day.

All students are required to wear the approved school uniform, with uniform colors limited to **navy, yellow, gray, white, and khaki**. Clothing must be neat, clean, and appropriately fitted. Students are expected to maintain a well-groomed appearance at all times. Detailed uniform guidelines and approved items are provided during enrollment. We have a partnership with Lands End in which our school can purchase uniforms but uniforms may be purchased anywhere as long as they meet our uniform requirements.

### General Guidelines

- Clothing should be clean, modest, and appropriate for school activities.
- Logos, images, or wording that are inappropriate, disrespectful, or contrary to Christian values are not allowed.
- Clothing should not distract from learning or draw unnecessary attention.
- Closed-toe shoes must be worn at all times (no flip-flops).
- Tops that provide full coverage (no low-cut, crop tops, or spaghetti straps).
- Pants or shorts that fit properly (no sagging, torn, or excessively tight clothing).
- Shorts, dresses and skirts must be of modest length.

### Special Guidelines

- Hats may be worn outdoors only.
- Hair should be neat and not distracting.
- Jewelry should be minimal and safe for active play.

### Spirit Days & Special Events

- Occasional “Free Dress” or theme days will be announced in advance. Students are expected to follow modesty and appropriateness standards even on these days.

#### Partnership with Parents

We rely on parents to ensure their children arrive at school dressed appropriately. If a student is dressed inappropriately, parents may be called to bring a change of clothes.

## **TRANSPORTATION**

PCA does not provide student transportation to and from school. Families are responsible for transportation. Students may not be dropped off at school before 8:15AM and must be picked up at 2:30PM promptly. A fee may be assessed for late pickups. Parents must send in a dated, signed letter if anyone other than a parent or emergency contact will be picking up a student from school. Emails will not be accepted for transportation changes. Phone calls should only be utilized on an urgent basis. Sending a signed letter with your child is the most effective and secure way to alert us to these changes.

The school may provide transportation for field trips and other special events. The school must have proper transportation waivers signed and on file before a student can participate in these events.

When dropping off and picking up students, please proceed with caution in the parking lot. The speed limit is 5 MPH. Please be aware of your surroundings and do not use cell phones while driving in the parking lot. Please do not allow children to run or play in or around the parking lot. For the safety of everyone, children should not be dropped off if a teacher is not present to accept the student.

## **LUNCH & SNACK**

Students will bring a packed lunch and snack daily. Students will have one snack break daily. Please provide a healthy snack item. If food needs to be kept cold or warm, please put it in a thermal container or put an ice pack in the lunchbox. PCA is not responsible for keeping food cold and cannot utilize microwaves to heat up packed food.

Please do not send gum, candy or soda to school. A small treat with lunch such as a small cookie or fruit snacks is okay but please refrain from including these items in daily snacks.

Please send a spill proof, filled non-glass water bottle for your child every day. Please make sure it does not leak. We kindly ask that you only send water in these water bottles. We will have water refill stations available.

We will occasionally have special snacks for a special day or event that may include sweets. You may also bring in a special store bought or bakery made snack for the entire class for your child's birthday (with prior teacher approval). Please no homemade items so that we can easily identify possible allergens.

We will monitor medical forms for student allergies and make accommodations with seating and guidelines as needed based on the allergies in the classroom.

## **VISITOR POLICY**

*This policy also applies to all chaperones and volunteers as well.*

To maintain a safe, respectful, and Christ-centered environment, all visitors, chaperones, and volunteers at PCA are expected to adhere to the following guidelines:

- Visitors must sign in, present ID if requested, and wear a visitor badge while on campus. Classroom visits require prior approval from school staff.
- Volunteers must complete a Volunteer Application, pass a background check, and follow all school rules.
- Chaperones for field trips or events must be approved by school staff, pass a background check, and closely supervise students.
- All visitors, volunteers, and chaperones must model Christian behavior and may not use alcohol, tobacco, or inappropriate language during school activities. All must dress modestly and appropriately for a Christian school.
- All visitors, volunteers, and chaperones must respect student privacy, never be alone one-on-one with a student (unless explicitly authorized), and act in accordance with our Christian values.

The school reserves the right to deny or revoke access to any individual who does not follow these policies.

**Substitutes are always needed, and we would love to have parents with schedule flexibility sign up as substitutes. Send the Head of School an email to inquire more.**

## **COMMUNICATION**

Providence Christian Academy acknowledges the importance of building a trusting relationship between our school and our families. To honor this commitment, we will communicate any pertinent information with parents in a timely manner using a variety of means including emails, text messages and phone calls, if necessary. We may also use social media as a means of communication. Teachers and staff may be reached at their school email addresses but should be given at least 24 hours to respond. The school office can be reached by calling 804.215.6750 during school hours.

## **EMERGENCY PROCEDURES**

PCA has established safety protocols to respond quickly and effectively to emergencies. Students and staff participate in regular drills for fire, severe weather, lockdown, and other urgent situations. In the event of an emergency, staff will follow these procedures to ensure the safety and well-being of all students.

## **VIDEO SURVEILLANCE**

For the safety and security of students, staff, and visitors, Gwathmey Baptist Church & Providence Christian Academy maintain 24/7 video monitoring of all public areas on church property. These recordings are used solely for security purposes, including the prevention of unauthorized access, investigation of incidents, and protection of church and school property. Personal privacy is respected, and cameras are not placed in private areas such as restrooms or where changing tables are able to be seen.

## **COMPLIANCE WITH CHILD ABUSE AND NEGLECT LAW**

The Code of Virginia, § 63.2-1509 provides in pertinent part that: any teacher or other person employed in a public or private school, kindergarten or nursery school; any person providing full-time or part-time child care for pay on a regularly planned basis; any

person 18 years of age or older associated with or employed by any public or private organization responsible for the care, custody or control of children; any athletic coach, director or other person 18 years of age or older employed by or volunteering with a private sports organization or team; who has reason to suspect that a child is an abused or neglected child, shall report the matter immediately to the local department of the county or city wherein the child resides or wherein the abuse or neglect is believed to have occurred or to the Department's toll-free child abuse and neglect hotline.

Please understand that we must take our obligations seriously and if we assess that a situation requires it, we will make a report to child abuse authorities of situations that we reasonably suspect constitute abuse or neglect. Depending on the circumstances, we may not be able to communicate with parents about the report until authorized by child abuse authorities to do so. We ask for your understanding as we do our best to protect the children under our care.

All PCA staff members have been trained in and will follow this policy.

## **FERPA REGULATIONS**

The Family Educational Rights and Privacy Act (FERPA) provides parents with access to their child's record.

## **FAMILY INVOLVEMENT**

We believe parents are a child's first and most important teachers, and we encourage strong partnership between home and school. Families are invited to participate actively in their child's education through communication, support, and engagement in school life. We welcome family members to volunteer and participate in school activities and events various times throughout the school year.

As Scripture states, *"And these words that I command you today shall be on your heart. You shall teach them diligently to your children, and shall talk of them when you sit in your house, and when you walk by the way, and when you lie down, and when you rise."* (Deuteronomy 6:6-7)

## **PARENT/FAMILY COMMITMENT**

At Providence Christian Academy, we believe that a partnership between the home and the school is essential to a healthy, Christian community. - We believe that discipline is necessary for the benefit of each student as well as for the entire school. We give permission to the teachers and administration to make and enforce school regulations in a manner consistent with Christian principles and discipline set forth in the Scriptures. We further agree that we will cooperate and discipline our child in the home as needed.
- We pledge that if, for any reason, our child does not respond favorably to the school, we will do everything in our power to cooperate with the school to help our child make the necessary adjustments. If these adjustments cannot be made, then we agree to quietly withdraw our child.
- We understand that financial assessments will be made to the parents to cover damage to the school/church by a student, including but not limited to breakage of windows, book damage, and the abuse of other school, church, or personal property. Cleaning fees may also be charged to the family if necessary due to an incident involving a student.
- We understand and will fulfill our financial commitment to pay for the educational services the school is providing for our children.
- We understand that the school reserves the right to dismiss any child who fails to comply with the established regulations and discipline, or whose financial obligations are not paid according to the agreed upon payment plan.
- We understand that PCA reserves the right to revise policies as needed.
